#### NOTICE TO THE PUBLIC

As agenda items are discussed by the Board during the Open Session of the Board Meeting, audience participation is permitted. The President will recognize those members of the audience who wish to speak.

The President will set a time limit on each person's remarks if he/she feels it necessary. Individual speakers shall be allowed three (3) minutes to address the Board on each agenda or non-agenda item. With Board consent, the president may increase or decrease the time allowed for individual comments. The Board shall limit the total time for public input on each item to twenty (20) minutes. With Board consent, the president may increase or decrease the time allowed for public presentation, depending on the topic and the number of persons wishing to be heard. The president may take a poll of speakers for or against a particular issue and may ask that additional persons speak only if they have something new to add. Generally, the President will ask Board Members for the remarks prior to recognizing requests to speak from the audience. At the President's discretion, agenda items may be considered in an order other than numerical order.

Closed Sessions may convene before, after or during the Regular Meeting. Closed Session items may include personnel, litigation, negotiations and/or student discipline.

(BACKGROUND: California School Boards Association provides districts with a recommended board policy manual and publishes legal updates for board policies. The attached Exhibit 4121 is needed to update the substitute pay in order to maintain competitive wages with surrounding school districts.)

C. Review notification of emergency approval of a purchase in excess of \$15,000 without prior board approval from Staples Office Solutions (Mike Pilakowski)

(BACKGROUND: To meet the needs of Gridley families without Internet services who have been required to move to a distance education model, Superintendent Reeves approved purchase of 100 cellular hotspots and service for loan to families totaling \$27,600 using special state COVID-19 relief funding. This item was not placed on a regular board agenda for approval due to the need to get the devices as soon as possible and due to the dwindling supply/availability of them through any vendor.)

A. <u>Approve 2020-21 Designation of California Interscholastic Federation</u>
<u>Representative to League</u> (Justin Kern)

(BACKGROUND: Nathan Link, GHS Athletic Director, is the primary representative for Gridley High School with Amber McIntire, GHS Assistant AD, and Justin Kern, GHS Principal, and Rikki-Lee Burresch, GHS Assistant Principal, serving as the alternates.)

B. Approve BR 25 – 1920 to allow onetime carryover of ASB funds from the 2019-20 year to the 2020-2021 school year for the 5th and 8th grade classes (Heather Navlor)

(BACKGROUND: Even prior to our current situation there has always been excess funds that were raised by the 8th grade class and the  $5^{th}$  grade class that have remained at their current school site rather than follow the students. Many end of year events will not be taking place and the students responsible for raising the money will not benefit which is contrary to requirement guiding expenditures.)

C. Approve annual Statement of Need (SON) for the 2020-21 SY (Julie Vang)

(BACKGROUND: The Annual Statement of Need must be filed at the school district office each year when employing holders of Emergency 30-Day Substitute Permits. It indicates that either no credentialed person is available or that those available are not deemed qualified for substitute teaching.)

**D.** Approve annual Declaration of Need (DON) for the 2020-21 SY (Julie Vang)

(BACKGROUND: The Declaration of Need (CL-500) is the annual form submitted to the Commission on Teacher Credentialing (CTC) by school districts that contains the employing agency's estimated number of Emergency Permits, Limit Assignment Permits and Internships that will be requested during the school year. In order to employ Interns and Permit holders districts must have a CL-500 on file with the CTC.)

## **E.** Approve purchase of office furniture and student desk from School Outfitters (Heather Naylor)

(BACKGROUND: Wilson Elementary School, Sycamore Middle School and Gridley School need new furniture and would like to purchase student desks and office furniture.)
