NOTICE TO THE PUBLIC

As agenda items are discussed by the Board during the Open Session of the Board Meeting, audience participation is permitted. The President will recognize those members of the audience who wish to speak.

The President will set a time limit on each person's remarks if he/she feels it necessary. Individual speakers shall be allowed three (3) minutes to address the Board on each agenda or non-agenda item. With Board consent, the president may increase or decrease the time allowed for individual comments. The Board shall limit the total time for public input on each item to twenty (20) minutes. With Board consent, the president may increase or decrease the time allowed for public presentation, depending on the topic and the number of persons wishing to be heard. The president may take a poll of speakers for or against a particular issue and may ask that additional persons speak only if they have something new to add. Generally, the President will ask Board Members for the remarks prior to recognizing requests to speak from the audience. At the President's discretion, agenda items may be considered in an order other than numerical order.

Closed Sessions may convene before, after or during the Regular Meeting. Closed Session items may include personnel, litigation, and negotiations and/or students discipline.

12. **INFORMATION ITEM(S)**:

Present First Draft of Learning Continuity Plan (Michael Pilakowski)

(BACKGROUND: SB 98 changed the statutory requirements for the 20-21 school year to remove the LCAP as a requirement of the year and replaced it with the Learning Continuity and Attendance Plan (being called the LCP) for the year. This is a shortened version that focuses more on school district responses to the pandemic and learning losses due to earlier and continuing school closures.)

В. Notification of Purchase in Excess of \$15,000 without Prior Board Authorization for **T-Mobile Hotspots** (Michael Pilakowski)

(BACKGROUND: Follow up phone surveys to the one that ended in May of 2020 plus addition of new families indicated that additional need existed in the school community for devices. Superintendent Reeves authorized an additional 100 hotspots from our approved allotment of up to 500 from T-Mobile's state-approved school connectivity program.)

C. Public Hearing Regarding Resolution #02-2021 Authorizing Budget and Cash **Transfers** (Heather Naylor)

(BACKGROUND: A Public hearing is a requirement of SB 98 education omnibus budget trailer bill2020 for fiscal year 20-21. The Butte County Treasurer requires all funds remain positive thorough out the year. During the 2020-21 year the Cafeteria Fund may need cash to meet the obligations of payroll because the state is slow in making the payments for reimbursable meals. This Board Resolution is required to provide the

authorization to transfer cash between accounts. The account that will be used to transfer to the Cafeteria Fund is the General Fund. The cash transfers are short-term and are repaid to the fund when the State makes payments to the district in the Cafeteria Fund.

Also, for the 2020-21 year the general fund will receive several months of deferrals starting in February 21. Should the general need additional cash the district will use the capital facilities fund for short-term borrowing.)

A. <u>Approve Resolution #02-2021 Authorizing Budget and Cash Transfers</u> (Heather Naylor)

(BACKGROUND: The Butte County Treasurer requires all funds remain positive thorough out the year. During the 2020-21 year the Cafeteria Fund may need cash to meet the obligations of payroll because the state is slow in making the payments for reimbursable meals. This Board Resolution is required to provide the authorization to transfer cash between accounts. The account that will be used to transfer to the Cafeteria Fund is the General Fund. The cash transfers are short-term and are repaid to the fund when the State makes payments to the district in the Cafeteria Fund.

B. <u>Approve Contract with Nichols, Melburg & Rissetto for Bus Barn Charging Stations</u> (Heather Naylor)

(BACKGROUND: With the addition of 3 electric buses the bus yard needs to install charging stations. NM&R will provide architect services for this project at a cost of \$15,000.)

C. <u>Approve Recognition and Appreciation to the Staff of Gridley Unified School District</u> (Jordan Reeves)

(BACKGROUND: The California Constitution prohibits public agencies from making gifts of public funds (Const., Art. XVI, § 6). To justify an expenditure, a district's governing board must determine that the expense will tangibly benefit the education of its students. If the governing board has reasonably determined that a particular type of expenditure serves a legitimate public purpose, courts will generally defer to the board's decision.)

D. <u>Approve Change Order for ICU Technology Cameras at Gridley High School</u> (Michael Pilakowski)

(BACKGROUND: Seeking to further improve the camera coverage at Gridley High School, GHS and Sycamore are asking for a change order to add three additional cameras to the approved project to provide additional coverage at GHS, and change one Sycamore camera out for a wider angle. The removed camera will be relocated to GHS as part of the order.)

E. <u>Approve I-Ready for 2020-21 School Year</u> (Michael Pilakowski)

(BACKGROUND: The I-Ready program for math and ELA (Reading) diagnostic and online instructional components have been at use at Wilson Elementary since 2015. The components are aligned to CCSS and the adopted ELA curriculum, Benchmark Advance.)

F. <u>Approve Additional Purchase of T-Mobile Hotspots and Service</u> (Michael Pilakowski)

(BACKGROUND: Would pre-approve the purchase of up to 300 additional hotspots up to the limit of the 500 total we have been allotted under the state's partnership with T-Mobile to provide improved connectivity during school closures.)

G. Approve Board Resolution 04-2021 Ed Code 44256(b) (Julie Vang) (BACKGROUND: Each year districts are required to certify that their teachers are teaching in their credential area. One mechanism for a district to authorize a teacher to teach a subject other than the subject specified on their credential is by Ed Code authorization. Ed Code specifies what a teacher must do in order to qualify to teach outside the area of their credential.

The teachers listed on this resolution have coursework in the subject areas they are teaching but are not authorized on their current credential to teach these subjects in a departmentalized classroom. The coursework they have in this area allows them to teach these classes under Education Code 44256(b).)

H. Approve Board Resolution 05-2021 Ed Code 44258.3 (Julie Vang)

(BACKGROUND: California has many provisions within the Education Code that provide avenues for the assignment of certificated employees outside their basic credential authorization. These Education Code options provide school districts with local level flexibility for staffing.)

I. <u>Approve Purchase Order Increase to Over \$15,000.00 for Emcor</u> (Kim Parks)

(BACKGROUND: Emcor provides a large portion of MOT's materials, supplies, and services at each school. We currently have reached the \$15,000.00 spending limit or have made emergency repairs and purchases with them requiring an increase to their existing Purchase Order.)

J. Approve Purchase Order Increase to Over \$15,000.00 for Hue & Cry (Kim Parks)

(BACKGROUND: Hue & Cry provides a large portion of MOT's materials, supplies, and services at each school. We currently have reached the \$15,000.00 spending limit or have made emergency repairs and purchases with them requiring an increase to their existing Purchase Order.)

K. Approve Purchase Order Increase to Over \$15,000.00 for Troy Farms (Kim Parks)

(BACKGROUND: Troy Farms provides a large portion of MOT's materials, supplies, and services at each school. We currently have reached the \$15,000.00 spending limit or have made emergency repairs and purchases with them requiring an increase to their existing Purchase Order.)
