**NOTICE TO THE PUBLIC**

As agenda items are discussed by the Board during the Open Session of the Board Meeting, audience participation is permitted. The President will recognize those members of the audience who wish to speak.

The President will set a time limit on each person's remarks if he/she feels it necessary. Individual speakers shall be allowed three (3) minutes to address the Board on each agenda or non-agenda item. With Board consent, the president may increase or decrease the time allowed for individual comments. The Board shall limit the total time for public input on each item to twenty (20) minutes. With Board consent, the president may increase or decrease the time allowed for public presentation, depending on the topic and the number of persons wishing to be heard. The president may take a poll of speakers for or against a particular issue and may ask that additional persons speak only if they have something new to add. Generally, the President will ask Board Members for the remarks prior to recognizing requests to speak from the audience. At the President's discretion, agenda items may be considered in an order other than numerical order.

Closed Sessions may convene before, after or during the Regular Meeting. Closed Session items may include personnel, litigation, and negotiations and/or students discipline.

(BACKGROUND: As a part of the requirements for California school districts, the District held a Public Hearing on June 16, 2021 to present the Local Control Accountability Plan (LCAP) to allow for public input on the plan following a series of public meetings in spring plus administration of a number of surveys to gather input from stakeholder groups. The final draft of the LCAP is now brought forward to the School Board for approval on June 30, 2021.)

B. [\*\*Approve Certification of the Original Budget for the 2021-22 School Year\*\*](#) (Heather Naylor)

(BACKGROUND: The Original Budget was presented for public hearing June 16, 2021 to allow the public to comment on its contents. Per Education Code Section 42127(a)(2)(B) requires a statement of the reasons that substantiate the need for assigned and unassigned ending fund balances in excess of the minimum reserve standard for economic uncertainties. The final draft of the Original Budget for the 2021-22 school year is now brought to the School Board for approval.)

C. [\*\*Approve Purchase from PLATT Electric Inc.\*\*](#) (Jordan Reeves)

(BACKGROUND: The current Gridley High School football stadium lights are 40+ years old, as such the lights are not working at full capacity. Over the past 3 years the stadium lights have shut down during football games causing delays in competition. This purchase will upgrade the lights to LED and allow for full functionality moving forward without any interruption during games or other events.)
