What are we working on?

- LCAP Around \$5 million in funding for 22-23 expected
 LCAP is Local Control & Accountability Plan
- Ongoing 3+ year plan (we are in year 1)
- Designed to focus on sustainable long term solutions and needs
- Can be spent on a wide variety of actions and services
- Requires an approved plan yearly with input
 - Two district surveys already went out in February
 - Sites conduct their own input-gathering as well



Feedback and input thus far

- 66 families responded so far to survey 1
- 40% feel loss of learning due to COVID
- 36% report mental health concerns for their children
- Concern about number of subs this year
- Get back to 100% normal ASAP (e.g. parents back on campus, no masks, return to rallies and events)
- Top five services GUSD should look at:
 - After-school Tutoring (46.4), After School Enrichment (44.6),
 Online Tutoring (32.1), Library Services (30.4), Summer Services (26-30%)

Feedback and input thus far (Eight State Priorities)

- Respondents reported most positive feelings about efforts in:
 - Basic Services Teacher Preparedness and Quality
 - State Standards Relevant and Up to Date Materials
 - Student Engagement and Attendance
- Respondents felt greater concern in:
 - Parental Involvement
 - Access to Arts
 - Facilities specific to the high school

Feedback and input thus far (Miscellaneous Trends)

- Plusses
 - Knowledgeable and caring teachers are common
 - Keep CTE pathways and look for more chances to provide real world experience and learning, including certifications
- Improvements
 - Improve quality and frequency of communication and parent events (esp. progress reporting)
 - Rewards/recognitions systems bring back, add, or make more frequent
 - Increase positive experiences on campus (clubs, activities, college connections)
 - Bullying, drugs continue to be a perceived issue



Pre-existing LCAP Goals, Actions, & Services

- LCAP Goal #1 All students will have a safe and supportive school culture, climate, and learning environment that encourage physical, mental, and emotional health
- LCAP Goal #2 All students will graduate from high school ready for college or career
- LCAP Goal #3 All students will achieve proficiency in core subject areas (ELA, Math, Science, Social Studies) as measured by state assessment data (CAASPP)



GUSD will receive approximately \$5,000,000 in 22-23 LCAP Funding

- Investigate additional bilingual parent support position
- Continue to support mental health, trauma, and safety (counselors, psychologist, PBIS, campus supervision)
- Continue to support additional safety initiatives (cameras, PA system, fencing, access control)

- Shift focus from AP to Dual Enrollment
- Continue to improve high school preparedness through work at Sycamore
